**Subject:-** Declaration of marks of online examination (Tier-I) held on 24, 25, 26, 27, 28/11/2025, 01, 02, 03, 04, 05/12/2025 & 08, 09, 10, 11/12/2025 for the post of Warder (For Male only) Post Code – 15/25 in Delhi Prisons & shortlisting of candidates for Tier-II (Part – I subject / qualification related paper, Part-II Descriptive Test) – regarding.

1. The DSSSB vide its advertisement no. 01/2025 dated 04/07/2025 had advertised Total 1676 (EWS-167, UR-680, OBC-452, SC-252, ST-125, including ExSM-179, SP-89) vacancies for the post of Warder (for male only) under post code 15/25 in Delhi Prisons with closing date 07/08/2025.
2. The online written examination was held on 24/11/2025 to 28/11/2025, 01/12/25 to 05/12/2025 and 08/12/2025 to 11/12/2025.
3. The marks obtained by 63817 candidates who duly appeared in the examination held on different dates as mentioned above have been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssbonline.nic.in](http://www.dsssbonline.nic.in).
4. Based on the performance in the Tier-I examination (online Mode), a total of 16596 candidates - (EWS-1670, UR-6806, OBC-3601, SC-2521, ST-1253, including ExSM-449, SP-296) (included bracketed candidates) who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Physical Endurance Test (PET), subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Physical Endurance Test (PET) separately-

5. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility as not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Physical Endurance Test (PET) does not entitle them any right over the post.
6. Reserved category candidates who have obtained marks above or equal to the last shortlisted candidates, have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
7. As per the Board Policy the minimum qualifying marks in one Tier the minimum qualifying marks in one tier written examination for UR/General /EWS is 40% for OBC 35%, for SC/ST/Phis 30% and for Ex-servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%.
8. The details of PET shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
